RECOMMENDED APPLICATION DETAILS

Schönox HPS 1100 is suitable for installing: Vinyl composition tile on suitable, cement and gypsum based substrates, approved plywood, terrazzo, radiant-heat subfloors, and properly prepared VCT and sheet vinyl, in interior areas

PACKAGING

· 4 gallons in plastic container

STORAGE

- · Store in cool, dry conditions.
- · Shelf life: 1 year unopened
- Containers that have been opened should be closed immediately.
- Remove any skin that has formed; do not stir in.

TECHNICAL DATA

- · Base: acrylic polymer
- · Color: light straw
- Storage temperature: 40° 95°F
- Working temperature: 65° 95°F
- Open time: up to 16 hours
- Drying time: approx. 30 60 minutes
- Immediate foot traffic, heavy traffic after 2 hours
- Final strength (prior to maintenance routine): 24 hours
- Coverage per 4 gal. unit when applied with notched trowel 1/16" x 1/16" x 1/16": 125-175 sq.ft. per gal., 1/32" x 1/16" x 1/32": 200-300 sq.ft. per gal.

All values are approximate and are subject to local climatic fluctuations based upon conditions at 70°F with atmosphere of less than 65% relative humidity following the recommended mixing ratio. Do not install underlayment or topping before the substrate has dried thoroughly.

DISPOSAL

Empty containers and dispose of in accordance with federal, state and local waste disposal regulations.
